1. The Chairman, Standing Cabinet Appointed Procurement Committee on behalf of the Sri Lanka Army now invites sealed bids from eligible and qualified bidders for purchasing of 75,000 Pairs of Boot High leg Black (Military Pattern) – for the Sri Lanka Army.
2. Bidding process will be conducted through National Competitive Bidding (NCB) Procedure.
3. Bids will be invited from the local manufacturers who possess at least 05 years experience in Boot high leg Leather manufacturing industry. Bidders who does not manufacture or produce the Goods, shall submit the Manufacturer's Authorization using the form included in Section IV of the Bidding Document. (Such Local manufacturer shall have at least 05 years experience in Boot high leg Leather manufacturing industry and the bidder shall have at least 03 years period of business registration in Sri Lanka).

7. In addition to the above, bidder shall pay Rs 65,000/- of non refundable fee (in cash to the Ministry of Defence) as sample testing charges.
