1.0 The Chairman Standing Cabinet Appointed Procurement Committee on behalf of the Sri Lanka Army now invites sealed bids from eligible and qualified Sri Lankan Business Entities, Manufacturers, Firms, and Limited Liability Companies and other establishments who intend to supply one or more of the following camps for the supply of Raw, Dry and Processed Food Items for the year 2018, for the stations with corresponding categories as per given in the following table. Contract period is 1st of January 2018 to 31st of December 2018.

2.4 Specific Instructions for each Category

- 2.4.1 Supply of All fresh foods Items to each camp in "Group -A" will be considered as separate bid. Bidder should bid for all the categories in each camp and all the items in a category. If the bidder fails to bid all the categories and items in a category above, bid will be considered as non - responsive. Bidder can bid (separately) one or more camps indicated in 2.1.1 to 2.1.83.
- 2.4.2 Supply of each category for an individual station in "Group -B" will be considered as separate bid. Bidder should bid for all food items in a category. If the bidder fails to bid all the food items in a category, bid will be considered as non - responsive. Bidder can bid (separately) one or more camps indicated in 2.2.1 to 2.2.8
- 2.4.3 Supply of each Dry Ration item to each camp mentioned in "Group - C" will be considered as separate bids. Bidders are allowed to bid one or more food items of each camp in "Group - C." The details of food items are indicated in the bidding documents. Bidder may contact the official lines indicated in para 11.0 for more details.

- 3.0 Interested bidders may obtain further information and may inspect bidding documents free of charge at the office of Commander of the Sri Lanka Army at address given in para 11.0 during 0900 to 1500 hrs on working days, until 1500 hrs on 09.11.2017.

Bids shall submitted to the office of Army Air Ticketing office complex, No.31, Kew Road, Malay Street, Colombo 02 and bids will be opened at the Ministry of Defence, 15/5 Baladaksa Mawatha, Colombo 03.

- 5.0 Bids will be called through the National Competitive Bidding procedure and foreign bidders are not permitted to bid.
- 6.0 Bidder shall have following Eligibility Criteria
- 6.1 Bidder shall be a locally registered Sri Lankan Business Entity.
- 6.2 Bidder shall not been blacklisted.
- 6.3 Bidder shall have any experience involved in similar nature business. If any poor performance reported and evidenced against to the bidder, total bids or one or more bids liable to rejection in bid evaluation.
- 6.4 Bidder shall have adequate cold rooms, warehouse, transport and freezer trucks facilities and the aforesaid facilities shall be maintained in satisfactory level.
- 6.5 Bidder shall have adequate financial resources.
- 6.6 When determining the total awarding quantity / total awarding sum for a specific contractor, the SCAPC shall consider the above capabilities mentioned in above 6.4 and 6.5.
- 6.7 Detailed descriptions of eligibility and qualification criteria has mentioned in the Bidding Document (Bidding Data Sheet).
- 7.0 Bids should be submitted on the forms purchased from the office indicated in para 11.0.
- 7.1 Bid in duplicate may be sent by post under registered cover or hand delivered to the address given in para 11.0. May be deposited in the tender box before the stipulated date and time as indicated in para 4. Late bids will be rejected. Bids will be opened in the presence of bidders or their authorize representatives who choose to attend in person at the address given in para 11.0
- 8.0 Bid shall be valid up to 30th of April 2018.
- 9.0 Bids must accompanied by a bid security which is valid until 28th of May 2018 Bid Security as well as bid securing declaration and addressed to Secretary Ministry of Defence in the format specified in section IV and the amount given in (Annex -D) to the bidding document.
- 10.0 Bidder shall submit manufacture authorization certificates when required.
- 10.1 Bidder shall submit the samples, when requested by the authorities of Food Procurement and Monitoring Unit of Ministry of Defence. If the bidder fails to submit the sample on or before the deadline, relevant bids may liable to reject
- 10.2 Pre-bid meeting will be held on, 30.10.2017, 1000hrs., at the Main Auditorium, 3rd Floor, Ministry of Defence, 15/5 Baladaksa Mawatha, Colombo -03.
