1. Applications are invited from Suppliers who wish to register themselves for the supply of items to Ranaviru Apparel for the year 2022/2023.

**MATERIALS**

- a. Accessories (Buttons, Snap Button(Silver Colour & Plastic), Interlining (Fusing), Zippers, Eye-lets, Silver Hook, Ribbon, Main Label, Size Label, Velcro, Velbone , Talc Sheet, Elastic, Rounded and Flat Elastic, Twill Tape, Waist Code & Code Stopper etc.)
- b. Fabrics Woven & Non-Woven – (Twill, Tricot, Single Jersey, Wet Look, Polo Knitted (PK), Polyester, Pocketing Fabric, Pyjama Fabric, Viscose, Poplin, Net Fabric (For Mosquito Nets) polypropylene etc.
- c. Rexene Materials/Diary Cloth, Sponge Sheets, Poncho Cape Materials etc.
- d. Sewing Thread.
- e. Packing Materials. (Poly Bags, Gum Tape, Cello Tapes, Label Rolls).
- f. Consumables & Needles. (Marker Papers, Plotter Papers, Bristol Boards, Box board, Screen Printing Ink, Ink Roll etc.)

2. All Suppliers are required to register either in Ministry of Defense (MOD), Rainbow Pages or Yellow Pages during the year of 2022.

3. All bidders are required to bid in the Sri Lankan Rupees and payments are done only through Ranaviru Apparel.

4. After selecting a supplier for a particular order, it's required to submit a bid bond for the total value exceeding Rs.500,000.00 and special attention may focus on Local producers.

5. All bidders should submit VAT Active Letter for 2022/2023 along with the VAT Registered Certificate issued from the Commissioner General , Inland Revenue Department.

6. All selected suppliers should supply according to the registered prices for the period of 31.05.2022 to 01.06.2023 and send your quotations according to the Sri Lanka Army given specifications.

7. Application forms could be obtained from the Accountant, Ranaviru Apparel, David Merick Peiris Mawatha, Kirindiwela Road, Yakkala on payment of a non-refundable fee of Rs.1000/= per category on any working day between 08.30 AM and 04.30 PM up to 09<sup>th</sup> March 2022.

8. Those who cannot call over could send by post an "Account Payee only" Cheque drawn in favour of "Ranaviru Apparel" and the application form would be sent to the supplier/contractor by post.

9. Registration forms may be sent by post under registered cover, or may be deposited in the box placed at the Ranaviru Apparel Factory Office. Applications will be opened at 02.00 PM on 10<sup>th</sup> March 2022.

10. Applications will be evaluated prior to registration.
