2. **Bidders who have been listed as “defaulted contractors” are not eligible to submit bids.**

3. Tender forms can be obtained from the office located at the above mentioned Army Cantonment/Camps on payment of a **non - refundable fee of Rs. 500/=** (Rs: Five Hundred) to the cashier stationed there. Bidders may submit bids for any number of lots and are required to forward separate tender forms per lot. (Eg : Vehicle tender forms cannot use for bids of General Goods) **One tender form should carry only one bid.** If bid for more than one lot, it is required to forward separate tender forms for each lot by paying Rs. 500/= each. The bids that contravene the above conditions will be rejected.

4. Refundable deposit specified in the relevant application form to be paid to the cashier stationed on site and the receipt Original copy of the receipt should be submitted along with the respective tender applications. **Any bid not accompanied with original receipt will be rejected.** Deposits will be confiscated if the bidders do not accept the tenders awarded.

5. Bidders should indicate the lot number of the Vehicles/ General Goods which is displayed on the front side of each Vehicle/ General Goods in the tender form as well as on the top left-hand corner of the envelope as shown below.

6. Sealed bids may be submitted through registered post or hand delivered. Hand delivered bids should be deposited in the relevant tender boxes provided separately for used Vehicles/ General Goods at the Cantonment/ Camps shown below from 0900 hrs to 1630 hrs on weekdays (except weekends and Public holidays). Hand delivered bids should be entered in the register book placed at the office before deposit in the relevant box.

7. Sealed tenders caring all details, documents should be deposited in the respective tender boxes or be sent by register post to reach the tender board chairmen on the dates and times specified in para 1 above. **Late tenders will be rejected.**

8. **It is mandatory for bidders or their authorized representatives (with a duly authorized letter by the bidder) to be present at the public bid opening along with their NIC/ Passport/ Driving License.**

9. The highest bidder or his authorized representative should pay 25% of the full amount at the tender opening when declared as the highest bidder and **They are required to bring sufficient money to pay 25% of the offered bid amount as a mandatory requirement (grace period will not be allowed).** The balance 75% amount should be paid in cash within 07 working days excluding the tender opening date. (Before 1600 Hrs of the 7<sup>th</sup> day). Cheques will not be accepted. Bidders are required to collect the tendered Vehicles/ General Goods within the maximum of 14 days (including weekends and Public Holidays) from the date of final payment. The refundable deposit and total payment of bid price will be confiscated of such bidders who unable to pay balance 75% payment and collect the tendered Vehicles / General Goods within the given period without any early notice.

10.. Even though the highest bid has been quoted for the respective Lot Numbers, such bidder or his duly authorized representative fails to be present on the Tender opening or before 1300 hrs on the same day or the highest quoted bidder refuses to buy the Vehicle/ General goods in writing, **the refundable deposits of such bidders will be confiscated immediately.** In the absence of such highest bidders or their duly authorized representatives during the specified period above, the refundable deposits in respect of Lots quoted will be confiscated. In such event the final decision will be vested with the Chairman, Tender Board whether to award the Tender to the next highest bidder or permanently remove such lots from the Tender having considered the estimated value and the difference of the highest two bids.

11. **Other considerable factors.**

a. Bidders who purchase tariffs free vehicles are required to pay relevant tariffs amount to Department of Motor Traffic in order to clear the vehicles and the details regarding the tariffs free vehicles and tariffs amounts will be informed by relevant SLAOC units.

b. It is the responsibility of the bidder to check and ensure the accuracy of vehicle chassis/ engine numbers (except for Scrap Vehicles) with the documents given by tender representatives. (Sri Lanka Army will not be responsible for any issue occurs after the completion of tender procedure)

12. All Bidders are required to submit their tender forms as per the stipulated conditions indicated in the respective tender form and this paper advertisement. The final authority with regard to the tender will be with the Chairman, Tender Board.
