



Sri Lanka Army Manufactures an Automated Disinfection Machine

An automated hand disinfection machine manufactured by the Sri Lanka Army Research Analysis Projection and Development Branch was introduced to His Excellencey the President of the Democratic Socialist Republic of Sri Lanka and Commander-in-Chief of the Armed Forces Gotabaya Rajapaksa at the Presidential Secretariat on 06 July 2021 by General Shavendra Silva WWV RWP RSP VSV USP ndc psc MPhil Chief of Defence Staff, Commander of the Army and Head of the National Operations Centre for Prevention of COVID-19 Outbreak (NOCPCO) representing the new inventors with Brigadier Sudath Udayasena Director (overlooking) Sri Lanka Army Research Analysis Projection and Development Branch.

The cost-effective machine produced by the Sri Lanka Army can store four litres of disinfectant liquid, and capable of sterilizing the hands of 600 people automatically for forty-eight hours after charging.



Heroes Reviving the Suffering

Beaches

Sometimes she is silent. Sometimes she turns into evil. But she is extremely sensitive. Therefore, a tiny thing could make her uncomfortable. She is passing her time of grief bearing all silently. There will be a day that she answers all these questions. That would be a day that we all tear. The story going to relate is none other than the story of the Goddess of Ocean around the island. The discussion of the beaches ones again came into discussion with the pollution made by the X- Press Pearl ship which carried the number of chemical containers and wrecked near the Colombo harbour devastating the NorthWest and southern shores.

The ship registered under the Singapore Shipping Company carried 1,486 containers, including 25 tons of nitric acid which can be used in the manufacture of fertilisers and




explosives, other chemicals, cosmetics and low density polyethylene pellets when it departed the port of Hazira on 15 May 2021 arriving off Colombo on 19 May 2021. The fire escalated 9.5 nautical miles North West of the Colombo Port. The environmental report which was submitted by the team of specialists working on Marine Pollution in University of Georgia headed by Prof Jena Jumbuckn in 2015 reveals that Sri Lanka ranked the 5th place among the countries who are affected by Marine Pollution. The Marine Biologists predict this situation may change with this incident. As per the report, 1.59 metric tons of unmanaged garbage is dropped per annum now.

With the intention to win the world leaders' attention on marine environment, the United Nations had proposed a mandate in 1992 at Rio De Genairo Earth Summit and declared 08 June as the World Marine Day. This concept was initially suggested by International Centre for Marine Development and Ocean Institute of Canada, However the wrecked X- Press Pearl has made a serious damage. In case the metal is mixed with the sea water, it challenges the survival of sea bacteria. Also, the situation strongly impact negatively on all ocean creatures including sea snails, star fish, and sea corals. The pollution on sea bed may develop further with the chemical mixture of the wrecked ship. The live corals die as a result of high rate ph Water. Death of the small fish specially in their breeding seasons, sea turtles, and developing a harmful seabed for sea creatures are inevitable. Sri Lanka has been named as the 5th among the countries who dump the plastics to sea water. Marine condition may even get worse with the plastics and the chemicals leaked by the ship.

Under such circumstances Sri Lanka Army is the only organisation who intervene to recover the suffering beaches. Sri Lanka Artillery Drone Team, Team of Bomb Disposal, Special team form Corps of 14 Sri Lanka Army Chemical, Nuclear, Bioscientific and Radiant Response accompanied with the troops from Sri Lanka Army Headquarters engaged in the task of repairing the lost beaches form North West to south beaches, upon the instructions of General Shavendra Silva WWV RWP RSP VSV USP ndc psc MPhil Chief of Defence Staff, Commander of the Army and Head of the National Operations Centre for Prevention of COVID-19 Outbreak (NOCPCO) and the inspection of Commander, Security Forces (West) Major General H M V L Liyanage RWP RSP ndu and 14,61,58 Divisions utilising the limited resources. The Sri Lanka Army has using the human resource at the crucial hours the ocean required the assistance, adhering the health guidelines to ensure the safety of coastal residents and the people.

This is not the only source where the local beaches get polluted. The nets of fishermen, plastics, and the raw materials abandoned to the sea including sewages caused massive leads. Therefore, it is better to bear in mind that the ocean is not anymore the dustbin of us but the lungs of the earth.

Generous Donation





Immortal Hero Sacrificed Life at Devastated Battle of Punarin...

The ocean waves hugged the shore attempting to melt the mighty rocks widely smiling with the milky foams. The young silver rays of newborn moon covered the village shinning the young leaves fluttering in the silent night. The time of the childbirth was around 1124 hrs on 21 September 1971. Before the midnight hours a young cry of newborn baby heaped the hearts of child expecting parents. Kariyawasam Wickramarachchilage Tilak Nishshanka was born rejoicing the family ones again in glee, being the second child to Mr Kariyawasam Wickramarachchilage and Katugampalage Punyasiri Dayawatie lived in Wellampitiya, suburbs of Capital. The young Tilak Nishshanka had a cheerful young day under

the shelter of his beloved parents and relatives. His acts of bravery were exhibited since his young days, but parents would never know what the destiny had stored in his life.

With the completion of the age to learn the letters, he was entered to DS Senanayaeke Collage in 1977 for his further studies. Hinting the good sign of dazzling future, he was mastered in both of his studies and extra-curricular activities representing various sports teams including Rugby and Soccer teams in school, embedding his name in the list of young athletics of the school play teams. Mr RIT Alas, his principal at the time where student Tilak Nishshanka studied, understood that the child's sign of bright future. Gleaming in the old goldern days, he raised his voice. "Tilak Nishshanka was an excellent student in the school. It was hard to say that he was excellent in sport rather studies particularly. But for sure he was genius in both. He often succeeded in the tasks he was entrusted by me or some teacher at the school. Therefore, he won the hearts of the staff not only the teachers who taught him but others". He was one of the prefects after he entered to Dhamma education to Sri Vijava Dhamma School and never missed the Katina (Holy Pooja of Robes during the Rainy Season) of Temple. Apart from that he was a leading candidate of every competition of public speaking events, drawings, and writings. His drama ones won the first place of Dhamma School Drama Coemption in 1987.

He had a special inborn talent for drawings. Young Thilak Nishshanka was the only artist of Vesak Pandol made by the temple in 1988. Head Principal of the Dhamma School and Registrar and Chief Adikarana Sangha Nayake, Thorapitiye Ananda Thero recollecting his memories on the Tilak Nishshanka said that the young lad had shown his talents in various ways since the day he admitted to the Dhamma school. He had gained prestige to the Dhamma

school wining many competitions of debates, singing, and drawings. "His 45 feet long Pandol what he made all of us surprised. His statue was erected in our Temple premises to motivate our younger generation to follow his path.".

When he was in grade 06, he joined the Cadet Team in the school in 1983 and became a Sergeant in 1990 of the same team. He succeeded into this position due to his talent troops controlling and leadership. Meanwhile, he achieved best results in GCE O/L with 05 Excellent Passes and 3 Credit Passes. He selected Commerce Stream for his GCE A/L and with the completion of the last task of education, he decided to join the Sri Lanka Army with the persistence to save the nation form the brutal terrorism escalating at the time on 07 September 1990 as an Officer Cadet. He was the best shooter in his intake defeating all the other competitors after getting the training from the Pakistan Military Academy. passed out from the Military Academy as a Second Lieutenant in 1991 and posted to the Fleet of Warriors named 3 Gajaba Regiment under the Officer No O/61672 and launched his national duty towards the nation as a Platoon Commander. His talent to lead the men in the fearsome battle was often praised by the followers.

He had portrayed his talent in tactical wisdom leading men in fearsome battles against LTTE at Wettalakarni, Palali, Elephant Pass and Magadal Battles and led many operations including Wickrama-1, Wickrama-II, Balawega in Northern areas. He determined to protect Punarin Camp in 1991 from the LTTE terrorists as it was one focal centre of operations. Terrorists had attacked the base in isolation over years with the intention of capturing it but failed. On 11 November 1993 around 0130 hrs a rain of rapid bullets reached the base unexpectedly where Lieutenant Nishshanka and his troops were deployed. Before the sharp counter


fire of Lieutenant Nishshanka's Team, the terrorist had to withdraw their attempt.

The warrior realised the terrorists are attacking encircling troops ruthlessly from either side. Without considering his desire for the life he led his troops to the battle ahead. Terrorists' mortars and RPGS were taking the innocent lives of his troops ruthlessly destroying the bunkers where the troops were taken the cover. Although encouraged the own soldiers the fire from the counter side was not decreased. Knowing the threat upcoming Lieutenant Nishshanka immediately reported the incident to the headquarters. But it was difficult to bring support troops as the headquarters was also caught to fire at the sametime.

Knowing the danger of hour, Lieutenant Nishshanka realised there is no option rather continuing the fire until the terror ceased He moved ahead encouraging the troops facing the counter fire fearlessly. Suddenly an enemy bullet pulls through his right hand and leg. Before the laments of beloved troops, he moved ahead with the wounded hand and leg with the soul cherished perseverance. He determined to destroy the enemies protecting his own troops. Without giving a second thought of his life, he took

his gun and pulled the trigger so sharp targeting the line of enemies approaching towards them. Soon he realized that the bullets of his gun were already ran out. Within few minutes he noticed the devastation occurs in case this enemies reached to his troops. He took his grenade, in the side pockets, removed the pin and jumped towards the approaching enemies knowing that saving own troops is better than falling into the hands of enemies as a brave lion. His beloved troops saw the scattering pieces of their beloved leader who sacrificed to save their lives in the fog of smoke wetting their eyes with the tears of respect.

Upon the exceptional gallantry exhibited in the individual act of bravery by Lieutenant Nishshanka in order to secure the lives of own troops neglecting the interest towards the own life was awarded Parama Weera Vibhushanya and promoted to the rank of Lieutenant from 2/Lieutenant. His service is yet remains unforgettable during the peak of the list of fallen War Heroes.

Law of War Revealed from Mahabharatha

No warrior must injure or kill a warrior who already surrendered was even known by the military heads of the ancient times. They had made aware their troops on this special law significantly. With the gradual expansion of the law over many years, it has converted to a powerful law which could impact solemnly to a state, country or world today. Kurukshetra War, revealing in the Mahabharata is the finest example to prove the existence of the Law of War in ancient times.

The War of Kurukshathra

Kurukshetra War, also famous as the Mahabharata War, is one of the

largest wars of history, as described in the epic poem of Hinduism, Mahabharata. The battle was a rising conflict because of the struggle of dynasty succession between the two groups of cousins, popularly known as Kauravas and Pandavas. Their traditional centre of the governance was Hasthinapuram which was ruled by Kauravas dynasty. Kauravas never involved Pandavas to the governance although lived in the same palace. The group of 06 cousins fought the Kurukshetra War for the throne of Hastinapur, and the War involved several prominent ancient kingdoms participating as the allies for the different groups. The master of the combat was Arjun form Pandavas and his adviser was Lord Krishna of Brindawan.

All the peace dialogues were exchanged through Lord Krishna.



Kauravas has greater respect towards this divine spirit of Brindawan. As soon the hope of the peace fall, the both Kauravas and Pandavas were ready to war and located in their traditional battlegrounds while the dates reaching closer to the war.

Rules Set Out by the Kurukshetra War

Commanders of supreme both the rival sides met before the beginning of the Kurukshetra War and framed "rules of ethical conduct". Many of the memevers were kith and keens of each. The Kaurava Army, represented by Bhishma (Commander), Donacharya, Thripacharya, Duryodan whereas the Pandava Army was led by Arjuna, Sahadev, Nakula, Satyaki, Shikhandi, Abhimanyu, Virata and Drupada. Dhrishtadyumna was the supreme Commander of the Pandava army. The discussion was headed by the Bhishma, the Commander of the Kaurava as he was the most senior of the both teams. The parents of the princes were also participated with their friend Lord Krishna. Accordingly, they set out the following rules before the battle.

- The war is between two parties of humans. Therefore, nonhumans such as Gods, divine spirits, devils and such forces are not allowed to involve the war.
- The war exists until one party completely defeats, and another party marks the victory.
- Fighting must only begin after the sunrise and end precisely at sunset.
- When the war concludes for the day, a warrior of the one party can meet the relatives of the rival party at night and such shall not be harmed.
- The warrior who surrenders, injured and becomes the war prisoner and will then be subjected to a war prisoner's protection.

- No warrior can attack any woman in such case identified womanhood during the battle.
- Leaders always fight with leaders. The rival soldiers are prevented to attack the leaders of the battle.
- Only one warrior can attack the other single one. No groups can attack individual people.

Protection and Violations of the Law of War

During the 7 day war between the Kauravas and Pandavas, Lord Krishna was appointed as an fight inspector to protect the first rule came into agreement. The deadliest war soaked the grounds in blood marked the incidents of both violations and protections of the enacted rules. During the battle a devil came into the battle making a great loss to the Kauravas. At the same evening the Kauravas interrogated the Pandavas for breaking the war rules. It was revealed then that a Pandavas prince had led a family with a female demon after escaped form Hastinapuram with the permission of the mother and the devil appeared in the battle was their son as he is belonging to Pandayas.

In another corner Kauravas killed isolated son of Arjun with a group attack. Prince Bheema of Pandavas, had cut the abdominal of the warrior who had dragged Queen Daupadee from hair and washed her hair back who was resting outside of the battlefield. Commading Warior Aswamanna of Kauravas slaughtered many young children during the last day of the battle. By the 7th day all the Kauravas had left their lives by the battle between relatives and friends. Finally, the Hastinapuram was taken by Pandavas and they ruled the kingdom with peace. As soon the battle marked end Lord Krishna departed to Brinda Wood where he used to live.

Present Situation of the Law of War



The Last Request

As I remember, it was the first week of May in 2009. We had reached the final countdown of the battle against Sri Lanka Armed Forces were able to limit the terrorists to area around 2 square kilometers in Wellamulliwaikkal and Nandikadal Bay. Many civilians were still detained by LTTE under their control using them as a human shield, therefore we had to select a careful way to reach them without harming the civilians. I was a Lieutenant Colonel at the time commanding to 17 Gemunu Watch which was newly established for Wanni Humanitarian Operation. I was the first Commanding Officer to this newly established battalion. Although my battalion is comparatively poor with the needful ration, uniform and the equipment, yet established fairly good lead in the battlefield. Strategically important Paranthan Junction was also captured by my battalion under command to the 58 Division on 01.01.2009. The morale of our team was high. The only hope blooming in the hearts of the Officers and the soldiers was the end of evil war with the greater perseverance.

At the time my battalion was moving towards the Wellamulliwaikkal Village which was the last identified enemy location. LTTE had built a huge soil bunt attaching Nanadikadal Bay covering the only entrance to the village. The route was pretty open and less with the natural concealments, Therefore my battalion was an easy prey to LTTE snipers and other heavy weapon attacks of the counter party. This huge soil bunt had to be crossed over anyhow to enter the last enemy location, therefore taking soil bunt under control was important as a initial stage of entrance. As there were many civilians taken as a human shield, the air and artillery assistance were not wise to be obtained. The situation had become severely complicated. Sine the superiority had passed the orders to assure no harm to single civilian who are under the LTTE custody, the responsibility on our shoulders was quite heavy. The attack to the soil bunt therefore should have done in a new way leaving the traditional tactics aside for a while.

Reaching to the soil bunt under the condition of less natural coverings was a challengeable task. The path we selected to move had been already trapped by various landmines by the enemy. My troops marched ahead carefully taking the soil bunt as a cover while facing the enemy attacks. However, before all these difficulties, my troops were able to reach 150 meters towards the soil bunt that LTTE had made. LTTE had made 3 meter trench just after the soil bunt risking the day march. Accordingly, everything was planned to lead the operation at night fall taking the cover of owl light. Accordingly, it was scheduled to capture a small part of the soil bunt.

There were handful number of Officers in my Battalion with its soon establishment and some platoons were commanded by Sergeants. I made the forward plan for the attack summoning my all Officers, Sergeants team leading Corporals and decide to divide the task among the several teams. One team will undertake the power of a part of soil and the other

team would assure the power around the nearby areas crossing the soil bunt from the area captured by friendly forces. A temporary ladder, wooden bridges were made to climb the huge soil bunt although it was hard and risky.

After planning the attack, we enjoyed a tea. While I was enjoying the tea, the team Sergent Pushpakumara, the leader of the C Team slowly reached me in fearsomely and obediently said that he wishes to enjoy a Cigarette with me. As per the military discipline, smoking before Officers by soldiers were strictly prohibited. Surprising the other soldiers and Officers, I shared a cigarette with him. Braking the silence, after passing a few smoke rings form cigarette Sargent firmly said "Sir, I will break this soil bunt however Sir !" I wished him patting his upper back, as I knew he is a brave and smart soldier.

The team 3 launched the attack at 0300 hrs and after a deadly and decisive combat, my soldiers were able to capture a part of the soil bunt. Soon after, I received a phone call form Captain in charge of C Team saying Sargent Pushpakumara is in serious condition as he caught for a LTTE clemo. Although the attack

was successfully carried out, Sargent Pushpakumara and few of my soldiers sacrificed their lives during the battle.

Sri Lanka Army was able to conclude the brutal terrorism on 19 May 2009 and I was happened to visit Sargent Pushpakumara's house on my way back home during my first vacation after concluding the battle. I informed that I was the Commanding Officer of their head of the house. His wife, still in grieve by the loss of her beloved husband, welcomed me holding their only daughter with tears. The young daughter in her age beginning to read and the sorrowful face of his wife brought me an nostalgic feeling for not understanding that his wish to share cigarette was his last request. I hopelessly looked at the baby girl laughing at me showing her shiny baby teeths.




Step to Cultivation

That excellent sportsman is none other than Corporal Ranathunga Karunananda of Sri Lanka Army who represented the country for in the Tokyo Olympics in 1994 for 10,000 Marathon event.

Accordingly, Corporal Karunananda had to face the run with the world class sportsmen represented the United States, Australia, Tunisia. Soon after the initial sign to start Corporal Karunananda without considering his sickness moved ahead with the bunch of sportsmen. Yet he continues his journey in the same speed he started the race while the other sportsmen mark the end making Corporal Karunananda the last who completed the marathon. With the start of 20 round world famous USA runner Billy Mills completed the run with 28 minutes and 17.6 seconds being the Gold medal owner. Even though the second and third places were already won, Corporal Karunananda is still determined to complete remaining 4 rounds while the others had given up the run. Accordingly, he continued his run as the same speed with the soul embedded perseverance and consistency. The audience at the

However, with this incident Corporal Karunananda was able to convey a message to Japan who fall being the victim of World War II. The Japanese authority entered Corporal Karunananda's story into Japanese textbooks highlighting his persistence bring a pride for his motherland Sri Lanka.
