- 1 The Chairman, Department Procurement Committee of the Sri Lanka Army, invites sealed bids from eligible and qualified bidders for the supply of undermentioned items for the year 2025.
 - a. Selected Contractors should transport under mention items ordered by SL Army to Base Ordnance Depot Ragama (BOD), Army Clothing Depot Veyangoda (ACD) or 1 st Regiment Sri Lanka Army Ordnane Corps Panagoda (1 SLAOC) as per the order copy.
 - b. Suppliers who are interested should submit their bidding forms which are obtainable from the Directorate of Ordnance Services, Sri Lanka Army Headquarters, Defence Headquarters Complex, Akuregoda Road ,Battaramulla (Army Vehicle Parking Area) during working days between 1000 hrs and 1500 hrs on below given dates on payment of a non-refundable application fee as indicated against each item in cash to the Director Finance, Sri Lanka Army Headquarters, Defence Headquarters Complex, Akuregoda Road, Battaramulla. Bids duly signed by the applicant should be submitted after placing the official seal there under as a compulsory requirement. The envelope containing the tender should be marked "BID FOR THE SUPPLY OF (Category of items) FOR THE YEAR 2025, Tender No (DOS/2025/......) and date/ time of opening of bids" on the top left- hand corner.
