INVITATION OF BIDS FOR PURCHASING OF SPARE PARTS & VEHICLE REPAIRING TO THE SRI LANKA ARMY FOR THE YEAR 2025

1 The Chairman, Department Procurement Committee of the Sri Lanka Army, invites sealed bids from eligible and qualified bidders for the supply Hardware, Wire, Gas, Paint, Rexine, Iron Items, spare parts, vehicle repairing for the year 2025.

a. All the services should be supplied to the location mentioned in the bidding document.

b. The Suppliers who are interested should submit their bidding forms which are obtainable from the Directorate of Electrical and Mechanical Engineering, Sri Lanka Army Headquarters, Defence Headquarters Complex, Akuregoda Road, Battaramulla (Vehicle Parking Area) during working days between 1000 hrs and 1500 hrs on below given dates on payment of a non-refundable application fee as indicated against each item in cash to the Director Finance, Sri Lanka Army Headquarters, Defence Headquarters Complex, Akuregoda Road, Battaramulla. The bids duly signed by the applicant should be submitted after placing the official seal there under as a compulsory requirement. The envelope containing the tender should be marked "BID FOR THE REPAIR OF (Equipment no) FOR THE YEAR 2025, Tender No (DEME/.....) and date/ time of opening of bids" on the top left- hand corner.

4. Bidders shall possess the following requirements to be eligible for submission of bids. The requirements will be considered under the process of the evaluation of bids.

- Sound financial capability.
- Satisfactory Tax payment records.
- Adequate repairing capabilities.
- Adequate Storage facilities (Warehouses).
- Adequate Staff, Personnel and Office facilities.
- Adequate transport facilities.
- Copy of Business Registration or Incorporation Certificate with an operational record of last three years.

5. The declaration of VAT Registration number along with the bidding document is a mandatory requirement for those who registered at Inland Revenue Department.

6. A letter of company authorization should bring to take the bidding document.

7. Bidding documents which are incomplete and not accompanied with required documentary evidence shall be rejected. The Chairman, Department Procurement Committee reserves the right to accept or reject any bid application and to alter the quantity of purchasing.

8. Selected bidders will be notified by registered post for signing of agreement.

9. Bidders will be paid by cheque .
